### SECTION 1 – GENERAL INFORMATION

**1.1 Project Title:** Professional Engineering Services for Design, Permitting, and Bidding of the Multi-Use Fields Renovations Project.

### SECTION 2 – SCOPE OF SERVICES

The Town of Bridgewater seeks proposals from qualified professional engineering firms to provide planning, design, permitting, and preparation of publicly biddable construction documents for renovation of an existing athletic field located at the Bridgewater Middle School property, 166 Mt. Prospect Street, Bridgewater, Massachusetts.

The project consists of renovation of an existing practice football field into a safe, durable, regulation-compliant multi-use athletic field designed to support football and lacrosse programming while improving safety, field performance, and long-term usability.

The project site encompasses approximately 2.25 acres of land located behind the Bridgewater Middle School and bordered by Crane Street, Pleasant Street, Winthrop Avenue, and Mt. Prospect Street.

The scope of services includes, but is not limited to: site preparation and regrading; drainage improvements; design of a high-performance athletic playing surface; automated irrigation system design; inspection and evaluation of the existing on-site irrigation well; field striping for football and lacrosse; energy-efficient field lighting design; preparation of all plans, specifications, permits, and publicly biddable documents; and assistance with the public bidding process.

The selected consultant shall inspect the existing irrigation well and provide a written report evaluating its condition, capacity, and suitability. Any required repairs or upgrades shall be clearly identified and priced separately unless otherwise directed by the Town.

All work shall comply with applicable federal, state, and local laws, regulations, and industry standards. Lighting design shall minimize off-site impacts.

## **SECTION 3 – PROCUREMENT PROCESS**

The contract shall be awarded to the responsible and responsive proposer submitting the most advantageous proposal, considering all evaluation criteria, including price, in accordance with M.G.L. Chapter 30B. The Town reserves the right to reject any or all proposals, waive informalities, and make an award in the best interest of the Town.

Proposals must include a detailed scope of work, firm qualifications, resumes of key personnel, related experience, and all required forms. Proposals shall be submitted in a sealed envelope marked "Planning, Design, Permitting, and Bidding of the Multi-Use Fields Renovations Project" and delivered to James Small, Park & Recreation Superintendent, 90 Cottage St., Bridgewater, MA 02324.

## **SECTION 4 – EVALUATION CRITERIA**

Proposals will be evaluated based on qualifications, experience, technical approach, past performance, and price. Proposals may be rated as Highly Advantageous, Advantageous, or Not Advantageous.

## **SECTION 5 – TERMS AND CONDITIONS**

The successful proposer shall maintain required insurance, indemnify and hold harmless the Town, comply with all applicable laws, and execute a contract subject to approval by the Town Manager. All proposals must be submitted without collusion.
