

Winter Street Improvement Project 2026

The work consists of removing and abandoning deteriorated corrugated metal pipe (CMP) drainage infrastructure. The installation of a new roadway drainage system consisting of reinforced concrete pipe (RCP), precast drainage manholes, precast catch basins, headwalls, precast drywells, and appurtenances within a major Town roadway.

Existing catch basins will also be removed and disposed of, and drain manholes will be left in place. This project also includes full-depth roadway reconstruction and realignment of Winter Street, as shown on the plans; water service relocations at interferences with the new drain line system; restoration of driveway aprons; tree removal; and lawn restoration in the vicinity of the roadway, along with drainage improvements. Bids shall be on a lump sum basis as indicated in the Bid Form.

Submittal Information:

Sealed Bids will be received until 11:00 a.m. local time on February 18th, 2026, at which time the Bids received will be publicly opened and read. Sealed Bids must have the outer envelope marked as "Winter Street Improvement Project 2026."

Responses to all questions received by Bidders will be compiled and e-mailed to all registered bidders by 4:00 PM on February 11, 2026, in the form of an Addendum. Failure by a Bidder to acknowledge receipt of addenda may result in bid rejection.

A bidding deposit of \$100.00 shall be furnished in the form of a check made payable to the Town of Bridgewater by all registered bidders requesting hard copies of the Bid Documents. The bid deposit shall be refunded to the registered bidders who return the bid documents in good condition at the bid opening. All bids must be submitted on printed hard copies of the PDF Bid Documents obtained via e-mail or from hard copies obtained from the Bridgewater DPW Offices located at 25 South Street, Bridgewater, MA 02324.
