## Rules and regulations are applicable to all groups utilizing the town fields.

- Alcohol and tobacco products are prohibited on all town parks and fields.
- The Applicant/User is responsible for ensuring the area is free of all trash and rubbish at the end of each use period. This includes the bagging and removal of all trash. This also includes depositing trash in Town provided waste dumpster at Legion Field. The waste dumpster is emptied weekly, if weekly trash exceeds the capacity of the provided dumpster, Applicant/User will be required to arrange for additional trash removal at their expense. A \$200 fee will be assessed for any excess trash that is not removed from the field.
- All banners or signs must be approved by the town recreation superintendent prior to being displayed on a town field.
- Dogs are not allowed on recreation playing surfaces.
- Users must leave the facility within 30 minutes of the permitted time.
- The Bridgewater Recreation Department requires that all youth organizations, coaches, and volunteers complete a CORI background check every year. Applicants must submit written evidence to the town that such background checks have been completed each year.
