** Note: if work falls within a riverfront area of a perennial waterway, the filing fee includes an additional 50% of the total mandated fee under the Wetlands Protection Act

\$4 per linear foot, total fee not less than \$100 or more than \$2000 a) Work on docks, piers, reventments, dikes, etc. (coastal or inland)

Notice of Intent - Category 6	\$2.00 per linear foot

Fee is \$2 per linear foot for each resource area. For each resource area delineation, the fee shall not exceed \$200 for activities associated with a single-family home or \$2000 for all other activities

ANRAD Review	\$1.00 Per linear foot of BVW & riverfront
Applicants pay \$1.00 per linear foot or bordering vegetated wetlands under the Town of Bridgewater Wetlands By-Law for wetlands reviews and riverfront reviews. This fee is in addition to the state and town mandated fees	
Category 1	\$200.00
Category 2	\$300.00
Category 3	\$1,000.00
Note: for Multi-Unit Dwelling structures the Commission imposes an additional filling fee of \$400.00 plus \$100.00 per unit where all or parts of the unit lies within the buffer zone, where all or parts of the unit lies within land subject to flooding and its buffer zone, where all parts of the unit lies within the outer 100 feet of a riverfront area

Determination of Applicability	\$300.00
Certificate of Compliance	\$200 single-family, all others \$300
On-Site Inspections	\$100.00 - 1st Inspection \$150.00 - 2nd Inspection \$200.00 - each additional
