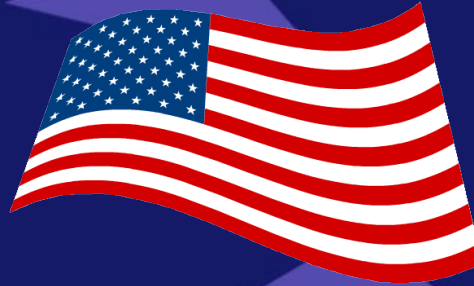
THE ROLE OF THE ELECTION WORKER

WHAT DOES AN ELECTION WORKER DO?

The election worker acts as the first point of contact for people seeking to exercise their constitutional right to vote.

Since elections generally only happen twice a year, the election process can be confusing for many registered voters. It's up to the election workers to keep things running smoothly on Election Day. Election workers perform numerous tasks, including the following:

- Check in all registered voters and distribute ballots
- Assist new voters in the registration process
- Monitor activities at polling locations to ensure compliance with Massachusetts State Election Law
- Count ballots in order to determine election results



QUICK FAQs

Election Workers are the officials who are appointed to represent the qualified party in which they are enrolled and are needed to provide a check and balance in the electoral process.

- Must be a U.S. citizen
- Must be a Bridgewater resident
- Must be a registered voter

WHY IS IT IMPORTANT?

The electoral process is the primary means by which citizens influence the course of our government.
