A RESOLUTION ON THE FISCAL YEAR 2013 BUDGET

WHEREAS: Article 6 of the Bridgewater Home Rule Charter sets out a process for the development and adoption of the annual operating budget and capital improvement program; and,

WHEREAS: As the Town Council wishes to establish a timeline, consistent with the Charter, by which it will provide policy guidance to the Town Manager on the development of the budget and capital improvement program; and,

WHEREAS: Such a timeline will also give town residents notice of their opportunity to offer input on these important financial matters:

NOW THEREFORE BE IT RESOLVED: That the Town Council of the City known as the Town of Bridgewater establishes the following timeline for the development of the Fiscal Year 2013 operating budget and capital improvement program:

- 1. The Fiscal Year 2013 Preliminary Budget Overview will be presented to the Town Council on November 15th, 2011.
- 2. The Town Council will adopt its Fiscal Year 2013 Budget Policy Guidelines by December 20th, 2011.
- 3. The proposed Fiscal Year 2013-2017 Capital Improvement Program will be presented to the Town Council by January 18th, 2012.
- 4. The Town Council will adopt its conceptual recommendations on the Fiscal Year 2013-2017 Capital Improvement Program by March 20th, 2012 subject to the availability of funds.

Proposed Resolution Order 2011-005:

A RESOLUTION ON THE INVESTIGATION INTO THE RECALL INITIATIVE EMERGENCY PREAMBLE

EMERGENCY MEASURE:

In accordance with Section 2-7(b) of the Home Rule Charter, An emergency measure shall be introduced in the form and manner prescribed for measures generally except that it shall be plainly designated as an emergency measure and shall contain statements after the enacting clause declaring that an emergency exists and describing its scope and nature in clear and specific terms. A preamble which declares and defines the emergency shall be separately voted on and shall require the affirmative vote of two thirds of the town council.

ORDERED: Where there is an active recall initiative with certified petitions delivered to the Town Council on October 19, 2011 necessitating the need to conduct an investigation under uncharacteristically short time constraints, thus creating an emergency which extends to the following legislation:

WHEREAS: The Town Council has the authority under Section 2-11 of the charter to perform inquiries and investigations into the affairs of the town,

NOW THEREFORE BE IT RESOLVED: Town Council of the Town of Bridgewater hereby moves to inquire and investigate the recall petition of two Councilors and any related matters in Bridgewater.

A RESOLUTION ON MASSACHUSETTS BEVERAGE CONTAINER DEPOSIT LAW

WHEREAS: The Massachusetts Bottle bill, enacted in 1982, has allowed Bridgewater residents to enjoy a cleaner environment by creating an incentive for users of certain beverage containers to recycle those used containers; and,

WHEREAS: States with deposit laws have higher residential recycling rates of beverage containers than those of non-deposit states, and;

WHEREAS: Litter decrease in states with Bottle Bills averages 70-85%, and,

WHEREAS: Through the Massachusetts Bottle Bill, we recycle nearly 80% of containers of deposit containers, but only 22% on non-deposit containers, and

WHEREAS: The Governor of the Commonwealth, and members of the Massachusetts Senate and House of Representatives have recognized that the original bottle bill does not take into account those beverages such as bottled water, sports drinks and teas.

WHEREAS: The addition of bottled water sports drinks, and teas to the Bottle Bill will decrease the total volume of municipal solid waste that is needed to be collected, thus saving disposal fees and landfill space.

NOW THEREFORE BE IT RESOLVED: That the Town Council of the City known as the Town of Bridgewater commemorates the 30th anniversary of the implementation of the Massachusetts Bottle Bill.

FURTHERMORE: Be it Resolved that the Town of Bridgewater be placed on record as being in support of the Massachusetts Beverage Container Deposit Law and encourages its strengthening through expanding the list as recommended by the Governor in his proposed budget and currently being considered by the House and Senate Joint committee on Telecommunications, Utilities and Energy.

FURTHERMORE: Be It Resolved that the Town of Bridgewater goes on record in supporting programs that encourage residents and visitors to return or recycle all beverage containers and other recyclable materials to fully utilize the currently available recycling programs.

BE IT FUTHTER RESOLVED: That the Town request that our state representatives, state senators and our Governor support and vote in favor of updating the Massachusetts Container Beverage Law.

WHEREAS: The sale of any Town owned land parcel shall not increase development on privately owned, land-locked parcels(s) and,

WHEREAS: Green Sale is defined as: Undeveloped land which shall remain undeveloped after the sale.

NOW THEREFORE BE IT RESOLVED: That all sales of Town owned land shall be made to increase "green space" within the Town of Bridgewater and that due diligence shall include assurance that all the sales of Town owned lands are consistent with a "green sales" goal.
