TOWN OF BRIDGEWATER DEPARTMENT OF PUBLIC WORKS BRIDGEWATER, MASSACHUSETTS ADVERTISEMENT FOR BIDS

Sealed Bids for the renovation and improvement of the "Town of Bridgewater, Carver's Pond Water Treatment Plant Valve and Pipe Support Replacement Project" will be received by the Department of Public Works at their offices located at, 25 South Street, Bridgewater, MA 02324 until 1:00 p.m. local time on July 10th, 2024, at which time the Bids received will be publicly opened and read. Sealed Bids must have outer envelope marked as "Town of Bridgewater, Carver's Pond Water Treatment Plant Valve and Pipe Support Replacement Project."

The work consists of the removal and disposal of all existing valves and pipe support system associated with the filters, the replacement in kind of said valves and pipe support system, and all labor, equipment and materials required for or incidental to the Work. Bids shall be on a lump sum basis as indicated in the Bid Form.

All Bids for this project are subject to the provisions of Massachusetts General Laws Chapter 30, Section 39M as amended.

Bid Documents will be available on May 29, 2024. Copies of the Bid Documents may be viewed electronically for informational purposes only by emailing the Department of Public Works at dpwbids@bridgewaterma.org. In order to be deemed properly submitted all bids must follow the bid submission procedure listed herein below. All questions relating to the bid documents and specifications must also be directed to this e-mail address by 4:00 PM June 20, 2024. Responses to all questions received will be compiled and e-mailed to all registered bidders by 4:00 PM on July 3, 2024. Bid Document packages will be emailed to vendors upon request. Addenda will be emailed to registered plan holders. Failure to not acknowledge addenda may result in a bid rejection.

A mandatory Pre Bid Site Visit at the Carver's Water Treatment Plant (100 Wellfield Drive Bridgewater, MA) shall be held on June 12, 2024 at 8:00 AM.

A bid document deposit of \$100.00, shall be furnished in the form of a check made payable to the Town of Bridgewater by all registered bidders. All bids must be based on the printed hard copies of the Bid Document obtained from the Bridgewater DPW Offices located at 25 South Street, Bridgewater, MA 02324. The bid deposit shall be refunded to the registered bidders who return the bid documents in good condition at the bid opening.

Minimum Wage Rates as determined by the Commissioner of Department of Workforce Development under the provision of the Massachusetts General Laws, Chapter 149, Section 26 to 27D, as amended, apply to this project. It is the responsibility of the Contractor, before Bid opening, to request, if necessary, any additional information on Minimum Wage Rates for those trades people who may be employed for the proposed Work under this Contract.
